 - Every child completing elementary education shall be awarded a certificate as (iv) laid down under rule 21.
 - Inclusion of students with disabilities/special needs as per provision of the Act. (v)
 - the teachers are recruited with minimum qualification as laid under section (vi) 23(1) of the Act. Provided that the teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years
